### **Anti-Ragging Policy of College**

PVG's College of Engineering and Technology and G. K. Pate (Wani) Institute of management Pune, has made strict policies against ragging and has absolutely zero tolerance for it. We are proud to state that our campus is totally ragging free.

#### What is Ragging?

Ragging constitutes one or more of any of the following acts:

- a) Any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or any other student.
- b) Indulging in rowdy or undisciplined activities by any student or students which causes or is likely to cause annoyance, hardship, physical or psychological harm or to raise fear or apprehension thereof in any fresher or any other student.
- c) Asking any student to do any act which such student will not in the ordinary course do and which has the effect of causing or generating a sense of shame, or torment or embarrassment so as to adversely affect the physique or psyche of such fresher or any other student.
- d) Any act by a senior student that prevents, disrupts or disturbs the regular academic activity of any other student or a fresher.
- e) Exploiting the services of a fresher or any other student for completing the academic tasks assigned to an individual or a group of students.
- f) Any act of financial extortion or forceful expenditure burden put on a fresher or any other student by students
- g) Any act of physical abuse including all variants of it: sexual abuse, homosexual assaults, stripping, forcing obscene and lewd acts, gestures, causing bodily harm or any other danger to health or person;
- h) Any act or abuse by spoken words, emails, post, public insults which would also include deriving perverted pleasure, vicarious or sadistic thrill from actively or passively participating in the discomfiture to fresher or any other student.
- i) Any act that affects the mental health and self-confidence of a fresher or any other student with or without an intent to derive a sadistic pleasure or showing off power, authority or superiority by a student over any fresher.

j) Any act of physical or mental abuse (including bullying and exclusion) targeted at another student (fresher or otherwise) on the ground of color, race, religion, caste, ethnicity, gender (including transgender), sexual orientation, appearance, nationality, regional origins, linguistic identity, place of birth, place of residence or economic background.

### **Measures to Prevent Ragging:**

Students and their parents are required to fill the Anti-Ragging Undertaking form online on the website <a href="www.antiragging.in">www.antiragging.in</a> or <a href="www.amanmovement.org">www.amanmovement.org</a> and submit signed printout of the affidavit is to the institution during admission ever year.

Awareness programs are conducted for the newly admitted students.

Anti- Ragging Awareness boards are displayed in the prominent places in the campus, Hostels and library.

Police patrolling is done twice a day by the nearest police station (Dattawadi Police station) to ensure a ragging free campus.

To ensure compliance as per the UGC Regulations on curbing menace of ragging in higher educational institutions, 2009, the Anti-ragging Committee is formed and headed by the Head of the institution. It comprises of representatives as prescribed by the UGC Regulations.

The committee will ensure compliance with the provisions of the Anti-ragging regulations; monitor and oversee the performance of the Anti-Ragging Squad for prevention of ragging in the institution.

The Anti-ragging committee members will frequently visit/inspect the different places in the college (Hostel, library, canteen, playground, etc.) to ensure that the campus is ragging free. While inspecting, the members must enquire with students regarding any incident witnessed or faced regarding ragging. The Anti-ragging squad will do surprise raids to the different places in the college (Hostel, library, canteen, playground etc.) at least once in each semester and make the report of the same.

The Anti-ragging squad can also plan a raid to catch the guilty red-handed whenever such an incident is reported in the campus.

In case of any incident of ragging in the campus, students can complain to the Anti-Ragging committee or Anti-Ragging squad as soon as possible.

The Anti-Ragging squad can call a meeting on an urgent basis to enquire/inspect the incident reported and provide the necessary support to the victim student.

The Anti-ragging squad can conduct on spot enquiry of any such incident of Ragging.

After inspection and enquiring, Anti-ragging squad will prepare a report as well as recommendation against the student/students found guilty and submit them to the Anti-Ragging Committee.

Depending on the report and recommendation established by the Anti-Ragging Squad, the Anti-Ragging Committee may decide one or more of the punishments listed below, to those found guilty;

- a) Suspension from attending classes and academic privileges.
- b) Withholding/withdrawing scholarship/fellowship and other benefits.
- c) Debarring from appearing in any test, examination or any other evaluation process.
- d) Withholding results.
- e) Debarring from representing the institution in any regional, national or international meet, tournament, youth festival, etc.
- f) Suspension/ expulsion from the hostel.
- g) Cancellation of admission.
- h) Rustication from the institution for periods ranging from one to four semesters.
- i) Expulsion from the institution and consequent debarring from admission to any other institution for a specified period.
