

Anti- Ragging

Redressal Mechanism

Measures to Prevent Ragging:

- i) Students and their parents are required to fill the Anti-Ragging Undertaking form online on the website www.antiragging.in or www.amanmovement.org and submit signed printout of the affidavit to the institution during admission every year.
- ii) Awareness programs are conducted for the newly admitted students.
- iii) Anti- Ragging Awareness boards are displayed in the prominent places in the campus, Hostels and library.
- iv) The Anti-Ragging Committee and Anti Ragging squad committee will be dealing with the cases / complaints of Ragging registered by the students of the institute.
- v) The Anti-ragging committee members will frequently visit/inspect the different places in the college (Hostel, library, canteen, playground, etc.) to ensure that the campus is ragging free. While inspecting, the members must enquire with students regarding any incident witnessed or faced regarding ragging.
- vi) The Anti-ragging squad will do surprise raids to the different places in the college (Hostel, library, canteen, playground etc.) at least once in each semester and make the report of the same.
- vii) The Anti-ragging squad can also plan a raid to catch the guilty red-handed whenever such an incident is reported in the campus.

Process for complaint registration:

In case of any incident of ragging in the campus, students can complain to the Anti-Ragging committee or Anti-Ragging squad as soon as possible, through the Helpline nos or email Id given below:

Procedure for investigation:

- i) As soon as the case is registered, the Anti-Ragging squad can call a meeting on an urgent basis to enquire/inspect the incident reported and provide the necessary support to the victim student.
- ii) The Anti-ragging squad can conduct on spot enquiry of any such incident of Ragging.
- iii) After inspection and enquiring, Anti-ragging squad will prepare a report as well as recommendation against the student/students found guilty and submit the report to the Anti-Ragging Committee.
- iv) Depending on the report and recommendation established by the Anti-Ragging Squad, the Anti-Ragging Committee may decide one or more of the punishments listed below, to those found guilty;

List of action taken against the guilty:

- a) Suspension from attending classes and academic privileges.
- b) Withholding/ withdrawing scholarship/ fellowship and other benefits.
- c) Debarring from appearing in any test, examination or any other evaluation process.
- d) Withholding results.
- e) Debarring from representing the institution in any regional, national or international meet, tournament, youth festival, etc.
- f) Suspension/ expulsion from the hostel.
- g) Cancellation of admission.
- h) Rustication from the institution for periods ranging from one to four semesters.
- i) Expulsion from the institution and consequent debarring from admission to any other institution for a specified period.


Depending on the nature and gravity of the incident, if required, the FIR can be registered to the nearest police station.
