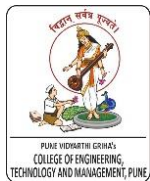

Rules and Process of admissions

- If any seat remains vacant or becomes subsequently vacant after CAP rounds, then it will be allotted to candidate belonging to same category for which it was earmarked during the CAP as per the Rule no. 13 published in the Information Brochure by State Common Entrance Test Cell, Mumbai, Government of Maharashtra.
- Vacant Seats after CAP will be filled in a transparent manner, **purely on merit basis**, as per the State CET Cell Information Brochure 2026-27 (page number 93 (h)),

- The Advertisement inviting applications for Vacant Seats after CAP is already published in newspaper and detailed procedure is as per the **schedule shown below**. The Candidates shall **register** by submitting the application link () and uploading the required **documents**.
- All the candidates reporting for admission must produce valid Identity Card (PAN/AADHAAR, etc.) and sign and collect the TOKEN of their Merit Number at the entry of admission venue. Only candidate and one parent will be allowed for admission process.
- **Reporting candidates**, who have applied for admission to this Institute and their name is appeared in the merit list, **must remain present personally**. Seats will not be offered seat to Parents. On announcement of Merit Number and name of the candidate, if candidate does not report, **he/she will lose his/her claim for the admission**.
- On offering the provisional seat/admission, candidate has to confirm admission by submitting two copies of all the required and applicable documents and pay full fees by Cash/DD/UPI payment immediately, otherwise the seat will be offered to the next candidate in the list. **Cheque will not accepted in any situation.**
- All those candidates who have registered their candidature with CET-CELL and being allotted application ID by CET-CELL are only eligible to apply for this round.
- All the admissions and cancellations will be updated instantly through online system. The admission will be confirmed only to those candidates who will deposit full fees of **₹1,38,701/-** approved by Fee/Admissions Regulating Authority, M.S. Mumbai for all category candidates.
- The candidate should deposit the full fees of **₹ 1,38,701/-** in Thane Janata Sahakari Bank LTD. (TJSB), Vidyanagari Extension Counter, Pune (located in college premises) by **Cash / UPI Payment (GPay, PhonePay, BHIM etc.) / Demand Draft (DD)** drawn in favour of "**PVG's COETM**" and **PAYABLE AT PUNE**.
